ASSUMPTION OF THE RISK AND RELEASE OF LIABILITY

I also understand that such risks are inherent to bicycle riding, which include bicycle equipment, roads, traffic, weather and other conditions which may affect safe riding and also risks which are also caused by my negligence and negligence of other people (including negligent rescue) who may be riding bicycles with me or who may participate in any bicycle event in which I might ride. I HEREBY ACKNOWLEDGE AND ASSUME ALL RISK OF MY DEATH, INJURY AND PROPERTY LOSS WHICH MIGHT RESULT FROM MY PARTICIPATION IN ANY AND ALL BICYCLING ACTIVITY SPONSORED, CONTROLLED AND OR ORGANIZED BY THE EAGLE CYCLING CLUB, INC. AND OR ITS MEMBERS, OFFICERS OR VOLUNTEERS.

I also understand that when I ride a bicycle, I may suffer death, serious injury and property loss by reason of the negligence of members, officers and volunteers of the Eagle Cycling Club, Inc. who may be riding bicycles with me or who may participate in any bicycle event sponsored, controlled, and or organized by the Eagle Cycling Club, Inc. in which I might ride or participate. I understand that such losses may result from negligent rescue by members, officers and volunteers of the Eagle Cycling Club, Inc. I acknowledge and agree that the Eagle Cycling Club, Inc. and or its members, officers and volunteers owe no duty to rescue me if I am injured while participating in any bicycle event sponsored, controlled, and or organized by the Eagle Cycling Club, Inc.

I EXPRESSLY WAIVE ANY AND ALL CLAIMS, CAUSES OF ACTIONS against the Eagle Cycling Club, Inc., its members, officers and volunteers which I might accrue by reason of any negligence (including negligent rescue) of any member, officer or volunteer of the eagle Cycling Club, Inc. in any bicycle event sponsored, controlled, and or organized by the Eagle Cycling Club, Inc.

I EXPRESSLY WAIVE, DISCHARGE, AND RELEASE from any and all liability for my death, injury and or loss of any kind or character which might accrue to me by reason any negligence of any member, officer or volunteer of the Eagle Cycling Club, Inc. in any bicycle event sponsored, controlled, and or organized by the Eagle Cycling Club, Inc. Although no member, officer or volunteer of the Eagle Cycling Club, Inc., owes any duty to rescue me in event I suffer an injury or loss while riding a bicycle, this waiver also applies to any injury, death or loss which I might suffer by reason of negligent rescue by any member, officer of volunteer of the Eagle Cycling Club, Inc. in any bicycle event sponsored, controlled, and or organized by the Eagle Cycling Club, Inc.

I EXPRESSLY AGREE TO INDEMNIFY, DEFEND (including the payment of attorney fees), SAVE HARMLESS the Eagle Cycling Club, Inc. and any and all if its members, officers and volunteers from ANY AND ALL CLAIMS, CAUSES OF ACTION which I might accrue by reason of any negligence of any member, officer or volunteer of the Eagle Cycling Club, Inc, in any bicycle event sponsored, controlled, and or organized by the Eagle Cycling Club, Inc.
